Tips and useful hints



Report schedule

For each of your initiatives, the 'Reports' tab will provide a list of all the reports you need to submit to the Foundation. There are three different report types: a status report, an annual report and a final end-of-project report. For each report, the overview will indicate the status and due date. You can access a specific report by clicking the report icon.

Reporting to the Foundation

Navigating to the report with the closest deadline will take you to this page. The reporting page has two elements: a Table of Content and an overview of the report content you are about to finalise for your funder.

The 'Run wizard' button starts the reporting guide that will help you through all steps of the reporting.

Please pay special attention to the following sections: Activities conducted, Collaborations that you have initiated, Sharing of results, and Influence on policy, all in relation to the current reporting period.

Reporting on activities


Reporting on the actual activities conducted within the report period is the most central part of your report. If you haven't already added any, the first thing you should do is to add the project activities that you have planned or are undertaking. The activity descriptions must be sufficiently precise and detailed for you to monitor and assess whether you have been successful in executing them.

We recommend that you report a maximum of five activities. To

include and report on an activity, use the 'Include in report' button. And describe the changes within the reporting period. Make sure to update both the metrics and progress so far for

both the metrics and progress so far for all activities that you report on in the current period.





Submit your report

When you have finished logging your activities, click the 'Submit 'button to make the report readable for your foundation. The report will stay in review mode for 60 days, during which time you can add or change information as requested by the foundation.
